As one of our founding Trustees steps down, we are looking for someone with legal expertise on our Board, to advise with matters of contract and employment law, as well as taking a broader interest in the development of the theatre company. This is an opportunity to join a largely newly-established Board at an exciting stage of Kandinsky's development, as we transition from fringe-favourites to a company making ambitious work for British and international stages.

We're interested in meeting new people from across the UK, with and without prior Board experience. Kandinsky is committed to equal opportunities and is particularly keen to encourage applications from candidates from Black, Asian, minority ethnic and POC backgrounds, as well as those from working-class backgrounds and anyone based outside of London.

Our Board currently comprises: Michael Walling, Artistic Director & Founder of the theatre company Border Crossings, who has been Chair of the Board since 2020; Lucy Williams, a freelance bookkeeper and finance manager in the UK theatre sector, who has particular oversight of Kandinsky's finances and accounts; Sofia Stephanou, Executive Director and Joint CEO of Arch468, who is helping Kandinsky to develop its touring networks; Jemma Tabraham, a freelance fundraising consultant and bid-writer, who is supporting the company to diversify its funding sources; and Roxan Kamali-Sarvestani, Community Engagement Producer at Talawa, who is working with us to challenge and extend our thinking on how engagement and education work fits into the artistic life of the company.







About Us

In the last seven years, Kandinsky has developed a reputation as one of the most exciting emerging theatre companies in the UK. From our regular home at New Diorama Theatre London, where we're an associate company, we've devised awardwinning shows on an eclectic range of subjects, from dogs to doctors to dinosaurs, united by a playful theatrical style that's both inventive and entertaining.

Recently, the company has built on its success with audiences and critics, beginning to create larger scale work with greater reach. In 2019, our show *Trap Street*, about the history of social housing in the UK, toured to the Festival of International New Drama at the Schaubühne, Berlin we also made our first main-stage commission, premiering *There Is A Light That Never Goes Out* at the Royal Exchange Theatre, Manchester.

Like all theatre companies, our work was impacted by COVID-19 - we were forced to cancel the off-Broadway transfer of our show *Dinomania* - but we have come back in 2022 with two new shows: *The Winston Machine* opened at the New Diorama in January, and *SHTF*, our first European commission, premiered at the Schauspielhaus, Vienna, in April.

We are currently working with our Board on growing Kandinsky into a company that regularly makes work for larger stages across Britain and Europe. We want to increase our UK profile, touring work regularly outside of London and developing educational programmes that allow more people to engage with the subject matters of our shows and the techniques we use to create them.

The company is run by writer and director James Yeatman and writer and producer Lauren Mooney.





Trustee roles and responsibilities


Kandinsky is a registered charity (no. 1134756) and a Company limited by Guarantee (no. 7169361). Board members have legal responsibilities as a Company Director, including making sure we are compliant with company and employment law, health and safety legislation, equal opportunities and laws around working with children and young people. You will read and sign off on our annual accounts and, together with the other Trustees, make sure we don't do anything that might place our funds, assets or reputation at risk.

This role has a particular focus on legal expertise: you will have familiarity with the law, especially those areas which are relevant to us, which may include: Charity Law, Copyright, IP, Contracts an Employment Law. We are working increasingly outside the UK, so familiarity with the legal repercussions of Brexit and European visa laws would be a bonus.

Ultimately, a Trustee's role is to support the company's work in whatever way feels appropriate to you and fits with your skills: helping the company grow, raising the profile of our work, challenging us in areas where we can do better or extending our knowledge base. We hope that being on the Board of a growing company will be exciting and that we can work with you to find a mutually rewarding way of working together, one that reflects your skills, experience and interests.

We do not expect our Trustees to donate to the company or ask others to do so. However, if any Trustees are willing and able to help us identify people who might become donors, this could form part of their work on the Board.
